"Andrew P. Pugno" wrote:

I'm writing to you confidentially, as one of the 5 official proponents of the Marriage Amendment (Senator Dennis Hollingsworth, Gail J. Knight, Martin F. Gutierrez, Hak-Shing William Tam, and Mark A. Jansson). In the last 3 weeks, we have been amazingly blessed with a great deal of support, both financial and otherwise, toward qualifying the Protect Marriage Initiative for the November ballot. Official signature gathering has started, both through the volunteer network, and through professional (paid) signature gathering. We have until April 21 to turn in the 1.1 million signatures need. At the moment we have over 50,000 signatures in hand, and thousands more coming in each day.

I do not think it is likely, but in the event you are contacted by the media or anyone else regarding the Marriage Amendment, I would encourage you to please refer all calls to the campaign phone number: (916) 446-5131. It is crucial that our public message be very specific.

In a few weeks, I will be contacting you regarding signing some paperwork in preparation for submitting the petitions for verification in April.
